

# CONTINUED PROFESSIONAL DEVELOPMENT FUNDING

A guide for those eligible for CPD funding.



### Introduction

In line with the 2019 Ministerial announcement of £150m increased investment in continuing professional development (CPD) for nursing associates, nurses, midwives and allied health professionals (AHPs) this guidance supports eligible individuals to access their £333. This funding will be distributed and managed through NHS England regional offices.

This guidance is intended to support CPD requirements of nursing associates, nurses, midwives and AHPs in NHS Trusts and GP Practices. This investment will allow access to funding linked to personal professional requirements as well as system and population health priorities. This funding aims to support the NHS, and support building skills and expertise of our workforce vital to services and communities.

### Eligibility

### Who can receive this investment?

Registered nursing associates, registered nurses, midwives, and allied health professionals in the NHS (in England) are eligible for the CPD funding. This funding settlement has been secured and agreed with HM Treasury specifically as part of the Department of Health and Social Care's negotiations for the NHS workforce in England.

This funding is not available for nursing, midwifery and allied health professionals in social care, local government or in other sectors outside of NHS in England (including CICs and social enterprises).

## Ways to access your funding

You can access your funding via two routes, these are;

To access external events, you will need to complete the funding request form. Your request will be reviewed for eligibility and confirmed by a member of the team.

### **COMPLETE FUNDING REQUEST FORM**

Click <u>here</u> to access the funding request form. Your request will be responded to within 2-3 working days.

### APPROVAL EMAIL

Before proceeding with any event bookings, you must ensure you have received your The Hub Plus approval email.

03

### **PAYMENT**

Payment can be made through direct payment to the event provider, or through reimbursement. You will be provided with further detail in the approval email.

### **REPORTING ANY CHANGES**

### **EVALUATION**

Once you have completed your training, you will be sent an evaluation form – this will allow us to measure the impact of the CPD funding to provide to NHS England.



### What is the funding intended to be used for?

The CPD funding will provide an individual development fund for frontline clinical professionals to:

- Equip them with new clinical skills to enhance the care they provide to patients and develop their careers.
- Support staff in moving between sectors, for example by enabling nurses and AHPs in hospitals to move to new roles in primary care and community care, supporting improved primary care access and out of hospital care.
- Support the maintenance of their continuing professional registration by helping them to meet requirements from their professional regulators.

Can the CPD funding be used for roles, i.e., secondments to rotational roles for leadership development?

No, CPD funding can only be used for the development of staff in these roles and not for salaries or backfill.

Can the money be used to pay for learning equipment like laptops / tablets?

No this cannot be included as this is capital expenditure.

### FAQ's

### Can the funding be used to pay for backfill to allow attendance at a conference?

Conference fees can be claimed if they fit within the agreed allocation for personal CPD. Backfill, travel or subsistence is **not** included.

Can the £333.00 be used as part payment for a more expensive course?

Yes

Can the money be used to pay for learning equipment like laptops / tablets?

No this cannot be included as this is capital expenditure.
